### **Mitigation and Prevention Strategies**

Bowlegs Public Schools will use ESSER III Funds to prevent and mitigate the spread of COVID-19, consistent with recommendations and guidance from the CDC on safely conducting in-person learning. Bowlegs Public Schools offered in person learning the entire 2020-2021school year. Many valuable strategies were learned that will help BPS to stay in class for the 2021-2022 school year.

#### 20% Set Aside to Address Learning Loss

Bowlegs Public Schools will reserve 20% of the ESSER III Funds for the purpose of addressing the loss of instructional time.

#### 80% of ESSER Funds dedicated to Allowable Uses

Bowlegs Public Schools will spend the remaining ARP-ESSER III Funds, consistent with the allowable uses authorized in section 2001 (e) (2) of the ARP Act. BPS will be responsible and follow the guidelines established by the State Department of Education.
